Watch Warranty Period: Harry Winston® watches: five (5) years from the date of purchase.

This Warranty covers material and manufacturing defects existing at the time of delivery of the purchased Harry Winston® watch (“defects”).

Where such defects become apparent during the warranty period and provided you present a valid warranty certificate, Harry Winston S.A. will:

- Repair your watch free of charge; or
- In the event that repairs are unable to restore the normal conditions of use of your Harry Winston® watch, replace your watch with a Harry Winston® watch of identical or similar characteristics. Such replacement watch will have the benefit of this Warranty for the remainder of the Warranty Period applicable to the original (replaced) watch.

Please be aware that:

- Goods presented for repair may be replaced by refurbished goods of the same type rather than being repaired. Refurbished parts may be used to repair the goods;
- Any data you store in your watch may be lost in the course of a repair. It is your responsibility to back up any data that may be stored in your watch before presenting it for warranty service; and

- The Warranty is only valid if the warranty certificate enclosed with your Harry Winston® watch upon purchase is dated, fully and correctly completed and stamped and signed by an official Harry Winston® retailer.
